Details:

On Wednesday, December 9, 2015 a Fulton Missouri man was arrested for possession of child pornography.

The investigation began in July 2015 when the Boone County Sheriff's Department Cyber Crimes Task Force received multiple CyberTip reports from the National Center for Missing and Exploited Children. The CyberTip reported a subject thought to be in the Fulton area had uploaded child pornography to multiple email accounts.

A Cyber Crimes investigator was able to identify the account holder as Malcom Buckner who was living at 7840 Cedar View Drive in Fulton. The child pornography files being uploaded to the email accounts were as young as 4 years old.

On December 9, 2015 the Boone County Sheriff's Department Cyber Crimes Task Force, along with the Callaway County Sheriff's Department served a search warrant at Buckner's residence. Investigators found evidence on a computer used by the suspect.

The suspect is identified as 44 year old Malcom Buckner of Fulton, Missouri. The suspect was arrested by Callaway County Sheriff's Department on suspicion of 1 count Possession of Child Pornography, 2nd offense over 20 images. Bond was set at \$50,000 surety.

All suspects are considered innocent until proven guilty in a court of law.

The Boone County Sheriff's Department Cyber Crimes Task Force is comprised of investigators from the Boone County Sheriff's Department, the University of Missouri Police Department, the Federal Bureau of Investigations and the Boone County Prosecuting Attorney's office.
