Incident: Man Arrested- Possession of Child Pornography

Location: Boone County

Case Number: 2016-4492

Details:

On Wednesday, October 19, 2016, a Boone County man was arrested for Possession of Child Pornography.

The investigation began in late July 2016 when the Boone County Sheriff's Department Cyber Crimes Task Force received a CyberTip report from the National Center for Missing and Exploited Children. The CyberTip reported a subject in Columbia Missouri had uploaded child pornography using a chat room.

A Boone County Cyber Crimes investigator was able to identify the account holder was living at the Sunny Vale Drive location in Columbia when the child pornography was distributed through Skype chat.

On October 19, 2016, the Boone County Sheriff's Department Cyber Crimes Task Force served a search warrant at the Deaver's residence. Investigators seized an electronic device used by the suspect to be analyzed. An on scene triage of the device determined the suspect was in possession of child pornography. Many of the images consisted of children as young as toddlers being raped.

The suspect is identified as 21 year old, Brandon Deavers who resides at 7280 Sunny Vale Drive , Apartment A located in Columbia, Missouri. The suspect is charged with 1 count, Possession of Child Pornography (more than 20 images or 1 video) 2nd offense.

All suspects are considered innocent until proven guilty in a court of law.

The Boone County Sheriff's Department Cyber Crimes Task Force is comprised of investigators from the Boone County Sheriff's Department, the University of Missouri Police Department, the Federal Bureau of Investigations and the Boone County Prosecuting Attorney's office.
