### Details:

On Friday, January 8, 2016 the Boone County Sheriff's Department Cyber Crimes Task Force along with detectives and Deputies with the Boone County Sheriff's Department arrested a 26 year old Franklin County man for traveling to a predetermined location in Boone County to have sex with a 14 year old.

The investigation leading to this arrest began 2 days ago when the suspect started conversing with an adult Boone County female through email who he believed had a 14 year old female daughter. The mom and child actually was an undercover detective with the Cyber Crimes Task Force. After exchanging several emails with the mom, the suspect wanted to meet in Boone County to engage in sex with the child. The suspect is alleged to have communicated with the adult decoy for the purpose of engaging in sexual conduct with the child.

The suspect is identified as 26 year old Jason Strubberg of 4275 Route Y, New Haven, Missouri. The suspect was arrested on suspicion of Attempted Enticement of a Child and Attempted Statutory Sodomy 2<sup>nd</sup>. The bond is a to be set.
