Incident: Sexual misconduct with a child/ Sex offender violation

Location: Boone County

Case Number: 2016-3158

Details:

On Friday, July 8, 2016, a 25 year old Boone County man was arrested on violation of sex offender registration (3rd violation) and an Internet related charge involving a child.

This is a direct result of the Boone County Sheriff's Department Cyber Crimes Task Force working proactive investigations involving the solicitation of children using the Internet.

The investigation leading to this arrest began early June 2016 when an investigator with the Task Force posing as a decoy child under the age of 15 had online communication with a male subject from Columbia. During the communication the suspect sent the child an image of his genitals. Further investigation lead to the identification of the suspect.

On July 8, 2016 with the assistance from the Boone County Sheriff's Department, Columbia Police Department and the FBI, a court ordered search warrant was served at 1612 N Providence Road in Columbia. The defendant was taken into custody and digital evidence was collected.

The suspect is identified as 25 year old Marquez Javaughn Williams residing at 1612 N Providence Road of Columbia, Missouri. The suspect was arrested on suspicion of Sexual Misconduct involving a child (Class D felony) \$4500.00 and 1 count Sex Offender Registration Violation (3rd Offense), to be set bond.
